Guidelines - Request for initial Connection, Metering Change or Service Alteration

Information and guidelines regarding completed Request for Initial Connection, Metering Change or Service Alteration Form

This form is only to be used when the work has been completed by an electrical Contractor.

The following mandatory information must be provided:

- (a) Sufficient detail to identify the customer and to locate the premises and metering position on site.
- (b) Details of the connection and metering arrangements and/or requirements.
- (c) Meter number of at least one existing meter unless this is an initial connection.
- (d) Details of the Electrical Contractor responsible for, and who tested the work. Note- If outgoing circuits are connected they must have been tested.
 - If a specific time is required on the date that the work is ready for connection, this needs to be arranged directly with SIEA, Please indicate and SIEA will contact you back to arrange a time- e.g. for a point of attachment change requiring electrical contractor to be on site.
 - If the sufficient information is not provided, the form will be returned unactioned.
 - Illegible and mutilated forms will not be accepted.
 - The Certification statement must be completed (signed) by the Electrical Contractor making the certification.
